#### 1.0 Chair

Stephen Hathway the chairman, opened the meeting at 2.00pm.

# 2.0 Attendance & Quorum

## 3.0 Committee reports.

**Accounts -** Balance Sheet and profit and Loss as at 30<sup>th</sup> June 2017 was tabled and the Chairman invited comment. The Chairman explained modest expenditure since the 30<sup>th</sup> June 2017 included expenses setting up AIIP's Brisbane Chapter.

### 4.0 Achievements

**4.1 Membership & Chapters** – The Chairman advised that in the preceding twelve months membership numbers had grown to 105 and regular Chapter meetings were now operating under the stewardship of Chapter presidents in Sydney (Stephen Hathway), Parramatta (Schon Condon) and Brisbane (Ginette Meuller). Efforts to open Chapters in Adelaide & Perth have commenced and continue.



- **4.2 Melbourne** AllP has through Stephen Hathway liaised with the *Melbourne Forum*, the regular membership of which was circa 40. Dialogue with the Melbourne Forum will continue as synergies and common interests are explored.
- **4.3 ARITA** ARITA & AIIP have developed a respectful working relationship that has delivered benefits to members of both bodies. The Chairman noted many members of AIIP are also members of ARITA.
- **4.4 Precedents** The AIIP has through its liaison and advocacy with ARITA made a significant and worthwhile contribution towards ARITA's preparation of precedents in response to the Insolvency Law Reform Act.
- **4.5 SME Committee** The AIIP has been advised by ARITA's John Winter (CEO) that ARITA is the process of establishing a SME Committee to ensure the interests of Insolvency Practitioners from smaller firms are communicated, understood and actioned in a timely manner. The SME Committee follows continues ARITA work with SME practitioners including the SME practitioners' Fiji conference.
- **4.6 Monthly Training** AllP's monthly training sessions have quickly developed an admirable momentum beneficial to AllP members. Presentations at the monthly training sessions from those charged with regulating our profession have proved interesting and helpful, as have the other presentations to the AllP membership.
- **4.7 Other benefits of AIIP membership** and regular attendance at monthly training include getting to know each other better and the friendships that accrue & endure therefrom.
